If submitting an essay you must include your name, address and phone number on top of your essay, and include your signature at the bottom of your essay. All essays must be originals and not mechanically reproduced. If mailing in an essay entry, to be eligible for the contest, such entry must be received prior to 11:59 p.m. (AST) on the Contest Closing date.

Entrants who are under the age of majority in their province or territory of residence must have their essays signed by a parent or legal guardian.

Participants who fundraise online will automatically be entered into the prize draw, after registering online, through the official Web site (<u>www.cysticfibrosis.ca/walk</u>), provided online pledges are received prior to 11:59 pm (AST) on the Contest Closing Date.
