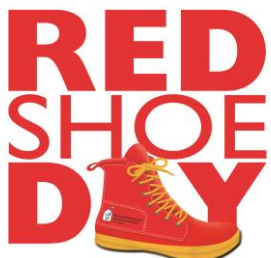

Voluntary Release and Waiver of Liability

In consideration of my or my minor child's ("Minor") participation in the "Red Shoe Day" event (hereinafter, "EVENT") sponsored and/or conducted by Ronald McDonald House Charities of San Diego, Inc. ("RMHC-SD") and their respective officers, directors, employees and agents (hereinafter, the "RELEASED PARTIES") I agree as follows, and with the understanding that "Participant" shall refer to the adult or Minor participating in the EVENT:

- 1. I know the nature of the EVENT and the Participant's experience and capabilities, and believe the Participant to be qualified to participate...
2. I and Participant FULLY UNDERSTAND that: (a) THE ACTIVITIES OF THE EVENT MAY BE DANGEROUS and participation in the EVENT and/or entry into restricted areas may involve RISKS AND DANGERS OF SERIOUS BODILY INJURY...
3. I consent to the Participant's participation in the EVENT and/or entry into restricted areas and HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS AND OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASED PARTIES."
4. I HEREBY RELEASE, DISCHARGE AND COVENANT NOT TO SUE the "RELEASED PARTIES" sponsors, advertisers, owners and lessors of the premises used to conduct the EVENT, FROM ALL LIABILITY TO ME, PARTICIPANT, my and the Participant's personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON ACCOUNT OF ANY INJURY, including, but not limited to, death or damage to property, CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASED PARTIES."
5. If, despite, this release, I, the Participant or anyone on mine or the Participant's behalf makes a claim against any of the "RELEASED PARTIES" named above, I AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE "RELEASED PARTIES" and each of them from ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS, LIABILITY, DAMAGE, OR COST THEY MAY INCUR DUE TO THE CLAIM MADE AGAINST ANY OF THE "RELEASED PARTIES" NAMED ABOVE, ASSERTING NEGLIGENCE ON THE PART OF THE "RELEASED PARTIES."
6. I understand that Participant may be included in media shots taken by RMHC-SD. I hereby authorize and consent that RMHC-SD shall have the absolute right to copyright, publish, use or assign any and all photographic portraits, pictures or video images, or audio (collectively "media"), or any part thereof, taken of Participant. I understand that I or Participant do not own or claim any rights to such media, and I release RMHC-SD from any and all claims, liability or obligation.
7. I sign this agreement on my own behalf and on behalf of the Minor, if Participant is a minor. I HAVE READ THIS CONSENT, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, UNDERSTAND THAT BY SIGNING IT I GIVE UP SUBSTANTIAL RIGHTS I AND THE MINOR WOULD OTHERWISE HAVE TO RECOVER DAMAGES FOR LOSSES OCCASIONED BY THE "RELEASED PARTIES" FAULT, AND SIGN IT VOLUNTARILY AND WITHOUT INDUCEMENT.
8. If signing this CONSENT, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT on behalf of the Minor Participant, I understand and acknowledge that I am lawfully authorized to sign on behalf of said Minor as his/her parent or legal guardian.

## Your Safety is our FIRST PRIORITY!

To ensure your safety in potentially dangerous areas, be aware of your surroundings and cautious of traffic rules. We suggest you go to your intersection prior to Red Shoe Day to:

- Find a safe place to park during the event.
- Explore the safest way to walk to your intersection.
- Identify the closest populated public area should an emergency arise.
- Locate your McDonald's drop-off point (indicated on the front of your packet).



## Day-of Safety Tips

Red Shoe Day is always a **crazy, fun, and energetic** day. With your help we can ensure the safety of all those involved! This way Red Shoe Day will continue for years to come!

### Work in Teams

Everything is better (and safer) with a buddy!

- Have one person hold the poster.
- Have the other hold the **Red Shoe** or canister.
- Use your free hand to pass out donation cards!



## Walking, Crossing, and Collecting at Intersections

Although it might be tempting to reach drivers at the far lanes of your intersection, it is important for your safety and the safety of drivers to follow the following guidelines.

- **STAY** on designated **sidewalks** and **crosswalks ONLY**
- **WALK**, do not run and make sure you stay visible
- Only cross when the light is **GREEN** or the WALK sign is on
- **Do not cross into the middle of an intersection** or step into oncoming traffic.
- **DO NOT STAND ON THE CENTER MEDIAN**





## Encountering Panhandlers

Your intersection may be a regular solicitation point for panhandlers. Here are some safety tips:

- If they approach you and are CALM, explain what you are doing and when you will be done. Usually they will let you occupy the corner without incident.
- If the panhandler is occupying your corner, ask them nicely if you can use it and explain what your intentions are.
- If they become aggressive and you feel threatened, **WALK TO THE NEAREST POPULATED PUBLIC BUILDING AND CALL THE POLICE.**



## Handling Money

- When your SHOE IS FULL, empty it into the provided bank deposit bag.
- Keep the **bag hidden from plain sight** in your tote.
- If possible, combine multiple bags and only **SEAL THE BANK BAG AT THE END OF THE EVENT.**



## Dropping Off Money

- **DO NOT** take your supplies into the McDonald's stores.
- An Ecolab employee will be in the **parking lot** of your designated drop-off point to collect your money and supplies between 9:30am and 10:00am.
- Each individual can return supplies and money to the drop-off point or a single individual may be elected to do the drop.
- **DO NOT** count the money. Please seal and return to the Ecolab employee as quickly as possible.
